The hydrophilic PTFE membrane does not require pre-wetting agents, thereby eliminating a potential source of contamination. The PTFE membrane is a low protein binding media. The capsules were designed with built-in luer loc caps for simple and efficient evacuation of air and liquid. The units are used for the filtration of small to medium volumes used in production, laboratory, and pilot runs. No adhesives, binders, or surfactants are used in the manufacturing process of these capsules. The filters are manufactured in accordance with GMP and comply with <USP 797> guidelines. The filters are flushed with pharmaceutical-grade purified pyrogens-free water, and 100% integrity tested prior to dispatch. Our filters and free from animal-derived components raw materials can be traced by Lot Number and are strictly regulated maintaining ISO 13485 & ISO 14001 quality standards.


